Overview

This document outlines major global grant opportunities exceeding \$1 million that are relevant for NGOs registered in India with the Foreign Contribution Regulation Act (FCRA) license. Selected Grant Opportunities

Develop Mitigations for Safety and Security Risks from Misaligned AI Systems

- **Deadline:** September 10, 2025
- **Donor:** AI Security Institute
- **Grant size:** Up to £1 million (~\$1.1 million) or more
- **Eligible applicants:** Researchers at academic institutions, nonprofits, and for-profit entities (with due diligence)
- **Focus:** Research on AI safety and security, interdisciplinary projects from computer science to cognitive science
- **Support:** Funding, cloud compute resources (AWS), expert mentorship, venture capital acceleration
- Note: NGOs with research programs in AI ethics or safety could consider applying.

EU Action Grants to Fight Against Anti-Muslim Hatred

- **Deadline:** October 23, 2025
- **Donor:** European Commission
- **Grant size:** EUR 20 million total budget
- **Eligible applicants:** Legal entities in EU or associated countries; international organizations may participate
- **Focus:** Projects combating racism, xenophobia, anti-Muslim hatred, and discrimination; includes awareness, support, reporting mechanisms, and community resilience
- **Relevance:** NGOs working on social justice, minority rights, anti-discrimination initiatives may apply.

Fighting Discrimination against LGBTIQ People and Promoting LGBTIQ Equality

- **Deadline:** October 23, 2025
- Donor: European Commission
- **Grant size:** EUR 20 million total budget
- Eligible applicants: Legal entities worldwide, including NGOs
- **Focus:** Projects addressing challenges faced by LGBTIQ people, especially vulnerable groups, intersectional discrimination, education, health, and inclusion campaigns
- **Relevance:** Human rights and social equality NGOs focusing on LGBTIQ rights may apply.

ADAPT: Advancing Sustainable Agriculture and Artisanal Fishing Program in Tunisia

- **Deadline:** October 30, 2025
- **Donor:** Italian Agency for Development Cooperation
- **Grant size:** €3 million total available; individual grants €1.5-3 million
- **Eligible applicants:** Nonprofit legal entities registered in EU or neighbourhood countries, with operational presence in Tunisia
- **Focus:** Promoting sustainability in agriculture and fisheries with capacity building and private stakeholder support
- **Relevance:** NGOs working on sustainable agriculture, community development, environmental resilience in developing regions.

Emergency Programme for the Protection of Refugees and Host Communities (Jordan)

- **Deadline:** September 15, 2025
- **Donor:** Italian Agency for Development Cooperation
- Grant size: Over €1 million per project
- **Eligible applicants:** Nonprofit entities with proven humanitarian experience, ability to operate on site
- Focus: Social protection, livelihood support, access to income-generation for vulnerable refugees and host communities
- **Relevance:** NGOs engaged in refugee aid, social protection, and economic empowerment programs.

2nd Open Call for Experiments (AI in Manufacturing)

- **Deadline:** September 30, 2025
- **Donor:** European Commission
- **Grant size:** EUR 1.5 million budget for about 10 projects

- **Eligible applicants:** Organisations in manufacturing sectors using AI for digital assistance
- **Focus:** Human-AI collaboration, digital assistance development, innovation in manufacturing
- **Relevance:** NGOs with technology innovation programs or partnerships in industry might collaborate.

General Eligibility for Indian NGOs (FCRA Holders)

- Many international grants accept applications from NGOs registered in their home countries with valid nonprofit status.
- FCRA registration in India is typically required for eligibility to receive foreign funds. NGOs must ensure compliances to meet donor due diligence.
- Partnering with academic institutions or international NGOs in consortia may enhance eligibility.
- Clear demonstration of project relevance, governance, impact measurement, and sustainability are critical.

Recommendations by ajazrashid.org

- Assess internal expertise and priorities aligned to the above themes (e.g., AI ethics, social justice, sustainable agriculture).
- Engage with partners for consortia-based applications where applicable (e.g., EU or Italian cooperation grants).
- Prepare early expressions of interest or concept notes for deadlines in Q3 and Q4 2025.
- Ensure documentation and reporting structures meet international donor standards.
- Investigate additional grants in the document for niche relevance and future cycles.

Impact Metrics

- Narrative with Stories and Testimonials: Complement quantitative data with qualitative evidence such as beneficiary stories, case studies, and stakeholder testimonials to humanize the impact and deepen engagement.
- **Scalability and Sustainability Indicators:** Demonstrate pathways for the project to scale and sustain long-term benefits beyond the grant period.

Governance

- **Transparent Organizational Structure:** Provide an overview of the governance framework, including board composition, roles, responsibilities, and operational accountability mechanisms. Highlight diversity and expertise on the board.
- Strong Financial Management: Emphasize robust financial controls, audit processes, and compliance with international accounting standards to assure funders of responsible fund use.
- Risk Management and Compliance: Describe policies for risk identification, mitigation (including compliance with local and international laws such as FCRA, GDPR), and ethical standards.
- **Stakeholder Engagement:** Illustrate how governance includes participatory decision-making involving beneficiaries, partners, and other stakeholders to ensure responsiveness and relevance.
- **Impact Reporting and Transparency:** Commit to regular, transparent reporting on project progress and financials, including mechanisms to share results publicly and with funders.

Additional Tips

- **Tailor Proposals:** Customize proposals to each grant's guidelines, emphasizing how the organization's governance and impact measurement meet funder expectations.
- **Leverage Partnerships:** Highlight collaborations with credible partners that strengthen implementation and governance capabilities.
- **Use Visuals:** Include clear charts, dashboards, and infographics in proposals to visualize impact data and governance structures.
- **Show Track Record:** Demonstrate past successful large-scale projects with documented impact and strong governance.

Which funding opportunities in the PDF are most realistic for Indian NGOs to target

- Other EU Horizon Europe grants like "Biotech for Climate Resilient Crops and Plant-Based Biomanufacturing" and "L'Oréal's Sustainable Innovation Accelerator Programme" offer opportunities to non-EU entities if meeting eligibility criteria.

Indian NGOs should confirm the eligibility clauses, especially related to geographic restrictions or requirements for legal registration, and consider collaborating with institutions or partners in eligible countries to meet funding criteria.

For strictly Indian NGO-targeted grants, the "Coordinated Call with India on Waste to Renewable Hydrogen" is directly relevant and open to Indian participation.

In summary, the most realistic opportunities in the PDF for Indian NGOs are:

- 1. Coordinated Call with India on Waste to Renewable Hydrogen (European Commission)
- 2. Develop Mitigations for Safety and Security Risks from Misaligned AI Systems (AI Security Institute) for research institutions/entities with AI focus.
- 3. ADAPT programs funded by Italian Agency for Development Cooperation for collaboration on sustainable agriculture.
- 4. EU and Dutch Research Council grants with open international eligibility where Indian NGOs can collaborate internationally.
